Background -

In 2013, a fertilizer plant containing ammonium nitrate exploded in West, TX killing 15 individuals and directly injuring at least an additional 252. Other disasters have been linked with mental health deficits among community members (Drescher et al., 2014; Makwana, 2019; Brackbill et al., 2013). The Waco-McLennan County Public Health District responded to a call from community members to conduct a follow-up study of the health status of residents living in West, TX.

Conclusions -

While this assessment cannot establish causation, it documents an elevated level of psychological distress in a rural community six years after a traumatic event. The estimated proportion of adults in West who experience PTSD exceeds the upper end of post-disaster estimates (30-40%), suggesting the chronic and mental health impacts a disaster has on a small rural community are long-term.

"West, Texas Follow-Up Study to the Fertilizer Plant Explosion in 2013." (Working Paper). (May 2019 - Present). The overarching aim of this study is to examine subsequent chronic health conditions among survivors of 2013 West Texas fertilizer plant explosion but can be broken down into two specific aims as follows:

- To examine incidence of mental health problems and chronic diseases
- To describe the change in the severity of pre-existing health issues and behavioral attributes (increased, remain same or reduced) among exposed individuals.

"Public Health Workforce Study: Burnout, Anxiety, Depression in Frontline Public Health Workers" (Complete). (August 2020 - August 2024).

This is a pilot study with 400+ frontline public health workers in 42 of 50 U.S. states documenting burnout, anxiety, depression, and other physical and mental health conditions due to the COVID-19 pandemic response.
